Promoting the Economic Interests of the Engineering Profession

At this point in my discussion of the objectives of COPE's Bylaws, my thoughts are bending toward "what did I get myself into?" The fourth objective is: "To promote the economic interests of the Engineering

profession". Does this seem inherently logical to everyone else? Or is the twist that we get this confused with promoting the economic interest of our engineering career or our engineering company?

I know the Professional Engineers of Colorado (PEC) are working toward this objective even though it may not be the primary reason for some of the programs and activities being discussed. At the PEC state meeting we had the opportunity to talk directly to the director of the State Board of Licensure for Engineers, *et.al.* about several issues related to who should be granted licenses and who should not; and what sort of continuing education requirements would be most beneficial for Colorado P.E.'s. We also voted to approve the development of a Civil Engineering P.E. exam review course with Kaplan University in Colorado beginning with the fall 2008 exam schedule.

By ensuring that licensed P.E.'s in Colorado have met educational requirements, engineering experience, and ethical performance requirements, the Board of Licensure provides a pool of engineers to the public who will "hold paramount the safety, health, and welfare of the public" (NSPE Code of Ethics for Engineers) in all the work they perform. As practicing engineers we justify the cost of our work by continuing to complete projects to this high standard.

Most large engineering companies that I have visited have photographs, drawings or scale models of some of their most memorable projects on display in their office. These displays help serve the purpose of promoting the economic interests of the engineering profession to a limited audience. The actual projects themselves provide an even greater display to a much larger audience.

Take pride in the engineering work you do, and don't be afraid to acknowledge the engineering you have done that goes into public projects. In the end, your acknowledgement will benefit all engineers.
